

## NOTICE OF CURRICULUM CHANGES 2020-21

### BIOLOGY MAJOR AND MINOR

**The following changes to the biology major requirements are applicable to students graduating in 2022 and later. The following changes to the biology minor requirements are applicable to students graduating in 2022 and later. Students graduating in 2021 may choose either the old or new minor requirements.**

BNS 360 (Drugs, Brain, and Behavior), BNS 370 (Sensation and Perception), BNS 380 (Behavioral Neuroendocrinology), and BNS 450 (Research in Primate Behavior) were added as an option to the major requirement:

Three additional three or four credit hour BIO courses numbered 300 or higher, including BIO courses not listed above (excluding BIO 400-405). The BMB courses listed above and/or BNS 330 can also be used toward this requirement. No more than two courses applied toward the upper-level requirements can be courses taught in another program (BMB or BNS).

BNS 450 (Research in Primate Behavior) was added as an option to the major requirement:

At least one of these six courses must also have a field-biology component consisting of at least 6 hours of supervised field research. BIO courses with a field-biology component include BIO 315, BIO 330, BIO 360, BIO 370, BIO 372, BIO381, and others to be determined by the BIO Program.

BNS 360 (Drugs, Brain, and Behavior), BNS 370 (Sensation and Perception), and BNS 380 (Behavioral Neuroendocrinology) were added as an option to the minor requirement of the Cell & Molecular Biology Track:

Three BIO courses numbered 300 or above from groups A [Cell and Molecular Biology] and B [Organisms] (excluding BIO 400 - 405). One of the following may be used to fulfill the upper level elective requirement: BMB 310, BMB 320, BMB 330, BMB 340.

The following language changed in the minor requirement of the Cell & Molecular Biology Track:

Of these three elective courses, at least one must come from group A and one from group B, and at least one must have a lab component (four credit hour courses). At least two of the three upper level courses must be BIO courses.

### BUSINESS MAJOR

**The following business major requirements are applicable to first-year students beginning in the 2021-22 academic year. The business major is not available to students that began in the 2020-21 academic year or earlier.**

ECO 110 (Introduction to Economics)

MAT 130 (Introduction to Statistics)

BUS 210 (Introduction to Management)

BUS 220 (Introduction to Marketing)

BUS 260 (Financial Accounting) – currently ECO 260

ECO 280 (Data Analysis and Communication)

BUS 340 (Managerial Finance) – currently ECO 340

Four additional BUS or ECO courses

One course from an approved list of *Business: A Liberal Arts Perspective* courses (An elective outside of BUS and ECO courses)

One course from an approved list of *Business and Society: Case Study Courses*

BUS 500 (Capstone Experience)

### DATA SCIENCE MINOR

**The following changes to the Data Science minor requirements are applicable to all current students.**

POL 205 (Introduction to Political Analysis) and POL 310 (Advanced Political Analysis) were added as options to the Analytics Elective course minor requirement.

## **ECONOMICS AND FINANCE MAJOR**

**The following economics and finance major requirements are applicable to first-year students beginning in the 2021-22 academic year. These requirements are not available to students that began in the 2020-21 academic year or earlier.**

MAT 130 (Introduction to Statistics)

MAT 165 (Modern Calculus-I) or placement in MAT 185 (Modern Calculus-II) or higher

ECO 280 (Data Analysis and Communication)

ECO 110 (Introduction to Economics)

ECO 210 (Macroeconomic Analysis)

ECO 220 (Microeconomic Analysis)

BUS 260 (Financial Accounting) – currently ECO 260

BUS 340 (Managerial Finance) – currently ECO 340

ECO 390 (Econometrics)

ECO 392 (Economic Forecasting) or ECO 395 (Empirical Analysis in Economics and Finance)

ECO 500 (Senior Seminar)

Three additional ECO courses numbered 300 or higher

## **ENGLISH MAJOR AND MINOR**

**The following changes to the English major and minor requirements are applicable to students graduating in 2023 and later. Students graduating in 2022 may choose either the old or new major and minor requirements.**

### **Requirements of the Major**

Eight 200- or 300-level ENG classes, no more than four of which can be at the 200 level

One 400-level ENG course (excluding ENG 400, 401, and 402, which are independent and directed studies)

ENG 500 (Senior Seminar)

At least one ENG class will be numbered 200-230, 300-330, or 400-430 (literature before 1800)

At least one ENG class will be numbered 270-299, 370-399, or 470-499 (transnational literature or literature from underrepresented groups)

One CRW class or one FLM class at any level can count as one of the required eight 200- or 300-level ENG classes

### **Requirements of the Minor**

Six ENG classes

At least one of ENG classes must be at the 300 level or above

Up to two classes can be CRW or FLM classes

## **FRENCH MAJOR AND MINOR**

**The following changes to the French major and minor requirements are applicable to students graduating in 2022 and later.**

### **Requirements of the Major**

FRE 221 (Intermediate Workshop)

\*\* FRE 210 (Intermediate Workshop) and FRE 220 (Intermediate Workshop) will count for this requirement for students who have already taken or who are taking those classes

FRE 261 (The Francophone World)

FRE 271 (Group Conversation)

Four FRE courses numbered 300 or higher

Two FRE courses numbered 150 or higher

FRE 500 (Senior Seminar)

**Requirements of the Minor**

FRE 221 (Intermediate Workshop)

\*\* FRE 210 (Intermediate Workshop) and FRE 220 (Intermediate Workshop) will count for this requirement for students who have already taken or who are taking those classes

FRE 261 (The Francophone World)

FRE 271 (Group Conversation)

Two FRE courses numbered 300 or higher

One FRE course numbered 150 or higher
